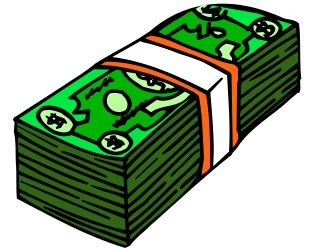


***You may qualify for \$3,408

The LIFE Scholarship (Legislative Incentives for Future Excellence) was signed into law in June 1998. This incentive funds \$3,408 scholarships per year* for eligible students attending Northeastern Technical College. You will also qualify for a \$150 per semester book allowance.

You may be a candidate for a LIFE Scholarship if:

- \$ **You are a South Carolina resident**
- \$ **You graduate with a SC high school diploma**
- \$ **Had a final GPA of 3.0**
- \$ **Currently enrolled or you plan to enroll in a full-time program at NETC.**
*(If you are a continuing student, you must have 30 college credit hours
and a GPA of 3.0).*
- \$ **You have NO felony, drug or alcohol convictions**
- \$ **You have NOT defaulted on a student loan**

**Programs at NETC are designed to be completed within two years. A \$3,408 scholarship is available each year for two years. LIFE scholarships are not available for the Summer Term.*

What do I need to do to apply for a LIFE Scholarship at NETC?

1. **Complete** the attached application.
2. **Read and sign** the attached affidavit that you have not been convicted of any felonies or any alcohol or any drug related offenses and that all transcripts have been submitted to the college.
3. **Turn in** the completed application to the NETC Admission Office as soon as possible to ensure adequate time in considering your eligibility.

South Carolina Law requires certificate of the following statement to be eligible for the LIFE Scholarship:

As a LIFE Scholarship recipient, I certify that I have not been convicted of any felonies. Further, I certify that I have not been convicted of an alcohol or drug related misdemeanor offense during the preceding calendar year defined as 12 months from the date of the start of school for the period of this award. If I am adjudicated delinquent or am convicted or pled guilty or nolo contendere to any felonies or any second or subsequent alcohol or drug related offenses under the laws of this or any other state, or under the laws of the United States, I understand I will lose this scholarship for the following academic year. I also agree to notify the Financial Aid Office by the start of school.

I hereby give permission for a background check to be conducted to verify the above. I understand additional information may be requested after the background check has been conducted.

Any false information provided by the student or any attempt to expend any scholarship funds for unlawful purposes or any purpose other than in payment or reimbursement for the cost of attendance at the institution authorized to award the scholarship and/or grant will be cause for immediate cancellation. Any student who has obtained a scholarship through means of a willfully false statement or failure to reveal any material fact, condition, or circumstances affecting eligibility will be subject to applicable civil or criminal penalties, including retroactive loss of the scholarship and/or grant.

I also affirm that I am presently not in default on any Federal or State student loans nor do I owe any refunds to any Federal or State financial aid programs.

For purposes of determining my LIFE Scholarship grade point average (GPA), I certify that I have submitted previous and current official transcript(s) for all South Carolina institutions I have ever attended. I also affirm that if I take courses after signing this document, I will submit any additional transcripts to my home institution. I understand that this information will be used to determine my LIFE Scholarship GPA only and will not be used for my institutional academic standing or for graduation purposes.
